

CLASS ORDER

Made pursuant to Section 22(5.0.1) of the
Health Protection and Promotion Act, R.S.O. 1990, c.H.7, as amended

DATE: July 2, 2020

TO: All owners and operators of agricultural farms in Hastings and Prince Edward counties who:

- a. employ migrant farm workers in any capacity;
- b. participate in the federal Temporary Foreign Worker program (TFW); and/or
- c. operate any model of seasonal housing accommodations.

Under Section 22(5.0.1) of the Health Protection and Promotion Act, a medical officer of health may make an order to a class of persons who reside or are present in the health unit served by the medical officer of health to take or to refrain from taking any action that is specified in the order in respect of a communicable disease.

Based on data available to Hastings Prince Edward Public Health, I am of the opinion that there is a high risk of increasing spread of COVID-19 within agricultural farms in Hastings and Prince Edward counties. The measures specified in this order are necessary to decrease or eliminate the risks to health associated with COVID-19.

I, Dr. Alexa Caturay, Acting Medical Officer of Health, for the Board of Health of the Hastings and Prince Edward Counties Health Unit, **ORDER YOU TO TAKE THE FOLLOWING ACTIONS**, effective 12:01 a.m. on July 3, 2020:

1. Ensure that all employees, current or future, are exclusively working within one workplace. Individuals who are employed at more than one facility must immediately limit their work to one premises.
2. Ensure that accurate and updated contact information for all employees (permanent, temporary, or contract) is available to be produced to Hastings Prince Edward Public Health (HPEPH) within 24 hours of request in support of case management and contact tracing requirements.

3. Follow any directions provided to you by HPEPH pertaining to COVID-19 and the terms of this Order. This may include ensuring adherence to self-isolation orders issued to employees, ensuring that required public health measures such as active screening and physical distancing are always maintained within your workplace, and supporting all aspects of investigations related to communicable diseases, including COVID-19 conducted by HPEPH.
4. Ensure that meals are provided to Temporary Foreign Workers completing isolation requirements. Meals must be nutritious and well balanced. Employers must accommodate dietary restrictions for workers under isolation. Workers under isolation must also be able to store food in a safe manner.
5. Ensure that potable water is always available to migrant employees under isolation or otherwise.
6. No Temporary Foreign Workers can be moved into a non-inspected living accommodation.
7. Ensure that HPEPH is contacted for pre-approval if renovations are proposed within pre-existing and approved living accommodations that impact floor space, number of faucets, toilets, showers, and/or bathtubs.
8. Ensure all individuals that are under HPEPH supervision for case and contact management have ongoing access to communication devices (cellular phone or landline) and this contact information is made available to HPEPH at all times. Individuals should not be sharing the device with more than 5 people and should be disinfected between users.
9. Ensure that all known instances of non-compliance with the Emergency Management and Civil Protections Act, Quarantine Act or isolation requirements are reported immediately to the appropriate agency.

TAKE NOTICE THAT each member of the class to whom this Order is directed is entitled to a hearing by the Health Services Appeal and Review Board if the member has delivered notice in writing to me (at the address below) and to the Health Services Appeal and Review Board (at 151 Bloor Street West, 9th Floor, Toronto, Ontario, M5S 1S4) requesting a hearing within 15 days after publication of this Order or otherwise in accordance with applicable law. In the context of the COVID-19 outbreak:

AND TAKE FURTHER NOTICE THAT although a hearing may be requested this Order takes effect when it is delivered to a member of the class or brought to the attention of a member of the class.

FAILURE TO COMPLY WITH THIS ORDER may result in further legal action being taken against you under sections 36(2), 35, 102 and other relevant provisions of the Health Protection and Promotion Act.

FAILURE TO COMPLY WITH THIS ORDER is an offence under Section 101 of the Health Protection and Promotion Act for which you may be liable, on conviction, to a fine of not more than \$5,000.00 (for a person) or not more than that \$25,000.00 (for a corporation) for every day or part of each day on which the offence occurs or continues.
